Like many behavioral health providers, Grafton used restraint when those in its care presented aggressive behaviors; when the initiative began, the organization reported over 1,500 seclusions and almost 7,000 restraints for 220 individuals. No training program was available to address this challenge. So Grafton created its own solution. Working with direct care staff and behavioral health experts, Grafton developed Ukeru, a cutting-edge program based on a core philosophy of Comfort vs. Control® and trauma informed care.
